Eligibility

- * Applicant must be a junior or senior during the 2019-2020 school year.
- * Applicant or their parent/guardian must be an active member of LEC.
- * Student cannot be a prior winner of the Youth Tour
- * Application and supporting reference forms must be returned to the LEC office by **5:30 pm on Thursday, November 29, 2018**

Application Process

- * Student must complete both pages of the **Entry Form** (attached) and submit to LEC by the deadline with the **Additional Supporting Information Sheet** (per Section II of the Entry Form).
- * Student must have a **Personal Reference Form and Evaluation Sheet** (attached) submitted by **three references** before the deadline. There must be at least one teacher reference and one community member reference. The third reference can be either of these.
- * Finalists must perform a 30 minute interview with LEC's Member Services Committee. Finalists will be notified by phone to arrange for their interview date and time.

[†]The trip begins with a flight out of Great Falls. The student and/or their parent or guardian is responsible for travel to and from Great Falls.
