# **78th Annual Meeting** LEC's 2025 Annual Meeting a record-breaking success

**O**<sup>N</sup> Saturday, April 12th, Lincoln Electric Cooperative hosted its 78th Annual Meeting at Lincoln County High School in Eureka – and it was one for the books! With 297 members and 349 total attendees, this year marked the highest turnout in recent years.

Guests were treated to a delightful spread of breakfast foods and desserts, all sourced from local businesses. Meadow Creek Cafe, The Gathering Place and The Farmacy served up breakfast favorites, while The Munchy Monkey and Café Jax offered sweet treats. Fresh fruit was provided by Watson's Market. Girl Scout Troop 3494 helped serve food with friendly smiles, and the LCHS Robotics Club wowed

attendees with a live demonstration of their innovative robots.

Every registered membership received \$20 in Chamber Bucks and was entered into a drawing for 37 fantastic door prizes — including multiple \$100 local gift cards, a Dewalt tool set, several coolers and the grand prize: a \$150 electric bill credit for an entire year!

The "Luck of the Draw" Scholarship program also saw a record number of applications, with 42 students applying and nine winners selected. A total of \$20,000 in scholarships was awarded, helping to support local students in

## Fortine school hits a homerun with baseball field backstop repairs

A Lincoln Electric Cooperative (LEC) board meeting in late 2024, administrators from Fortine School made an in-person visit to request assistance with repairing the school's aging baseball field backstop. The structure was in poor condition and posed safety concerns for players and spectators alike.

After hearing a detailed explanation of the situation, the LEC Board generously agreed to have LEC donate the time, materials and manpower needed to make the field safe once again.

As the weather improved and roads reopened to heavy equipment in late April 2025, LEC linemen assembled a crew and headed to the site to begin repairs. The work involved removing four old utility poles that were rotting and leaning dangerously toward home plate. In addition, the crew dismantled the mismatched, worn-out wire netting and replaced it with new, durable fencing. Treated wooden supports were also replaced with new materials to ensure long-lasting strength.

In just a day and a half, the LEC crew successfully completed the project, removing and properly disposing of all the old materials and installing a brand-new backstop using sturdy poles, supports and wire fencing.

This effort was a shining example of community support and teamwork, something LEC is proud to be a part of. Special thanks go to a select InterBel crew for their help with the removal of a particularly tricky pole, and to the Fortine School groundskeeper for providing gravel, answering questions and offering on-site assistance.
