Trustee Election 2026

INCOLN Electric is guided by an eight-member Board of Trustees — elected by you, our members. Each trustee is also a co-op member, bringing their own experiences and perspective to help shape the future of Lincoln Electric.

Lincoln Electric's service area is divided into two districts, with each district having at least two representatives on the board. Trustees serve three-year terms, with three seats up for election each spring. Election results are announced at the Annual Meeting.

What are their responsibilities?

Collectively, your Board of Trustees is responsible for establishing, reviewing and revising corporate policies to ensure Lincoln Electric continues to prioritize service to its members while maintaining a stable, competitive position in the industry.

Your trustees also understand the importance of community involvement. They know the members come first — because they are members, too. They live and work right here in our communities, and they are dedicated to making life a little better for us all.

Who's up for election this year?

Three seats are up for re-election in 2026:


- Myra Appel District 7

Interested in Running?

Serving as a trustee is a great way to represent your neighbors and make a difference in our co-op. To become a candidate for a Lincoln Electric Cooperative, Inc. (LEC) trustee seat, nominees must:

- Be an LEC member currently receiving electric service.
- Have their primary residence and associated electric service within the district they wish to represent.
- Submit a completed petition to LEC and include the names and signatures of at least five (5) valid LEC members whose primary residence is within the nominee's district. (Endorsement spaces are provided on the back page of the



petition.)

While only five signatures are required, we recommend gathering additional endorsements in case one or more memberships are invalid.

The petition must also be signed by the nominee, confirming his or her understanding and acceptance of the responsibilities of the trustee position if elected.

WINTER IS HERE

Tips to keep warm without breaking the bank

The woodstoves are burning, the snow shovel workout program has started and most of us are wondering how on earth it's dark at 5 p.m. At Lincoln Electric Cooperative, we know cold weather means more electricity use — but with a few simple tips, you can stay cozy and keep those bills from climbing higher than the snow drifts outside your front door.

Heat Without the Headache

Thermostat tug-of-war. Every degree you turn down the heat can save you up to 3 percent on your bill. (So yes, when Grandpa says "put on a sweater," he's not wrong.)

Blankets beat kilowatts. A fleece throw or flannel sheets do wonders. Plus, they don't raise your bill.

Plug Those Pesky Drafts

Find the leaks. If your house whistles when the wind blows, it's time for some weatherstripping or caulking.

Insulate like a pro. Attics, basements, crawl spaces — these spots love to steal your heat. Beef up the insulation and keep that warmth inside where it belongs.

Curtains have a job, too. Open 'em during the day for free sunshine, then close 'em at night to keep Jack Frost outside where he belongs.

Everyday Energy Savers

Appliance teamwork. Only run the dishwasher or washing machine with full loads—half loads just waste energy (and soap).

LEDs are a bright idea. They use about 75 percent less energy and don't burn out when you need them most.
